

Minutes of the remote meeting of Staverton Parish Council held on Monday 15 March 2021 at 7.00 pm.

This meeting was held via Microsoft Teams

The meeting commenced at 7.00 pm.

80. MINUTES OF THE LAST Meeting held on 18 January 2020 was held to be a true record.

81. PLANNING APPLICATION 21/01038/FUL

Proposal from Cereal Partners to build new sprinkler taps, pump house and associated foundation base. Cllr Mark Frati proposed and Cllr Jeff Gibson seconded that there was no objection to this application. The motion was carried unanimously.

82. RESIDENT/COUNCILLOR MATTERS

- a. Request to channel complaints through the website: A recent anonymous complaint was emailed to the Parish Clerk. Although it related to a planning issue and would need to be fully investigated, it was also noted that this was personally directed and mischievous in its wording. It was considered unnecessary to provide an official complaint form on the Parish Council website, but in future any complaint must be from an identifiable source for DATA Protection reasons. Action: In future, Clerk to ask for identification from complainants.
- a. Health and Safety Report for Play Area School Lane: The recent report from N Adams, pointed out that that the basket swing no longer complied with British Standards. The cost of upgrading the swing was nearly £1,300 and this was considered prohibitive with very little income received from hires due to the current pandemic. A decision was made to remove the swing until Parish Council finances improved. Action: Parish Clerk to discuss this with Cllr Trevor Carbin to see if an Area Board Grant can be obtained to help with the cost. Cllr Jeff Gibson to contact British Gas to see if they can repair the cabinet situated in the play area. Cllr Mark Frati said he would try to obtain free topsoil for the uneven areas of the site.

83. SPORTS GROUND AND VILLAGE HALL

a. Toilet for Football Teams: With Government restrictions being lifted for football activity on the sports ground on 29th March 2021 concerns were raised that hirers were not emptying waste bins in the toilet as required by the Covid 19 rules. The rules will be impressed again on users and it will be monitored. Action: Clerk to contact the contract cleaner to deep clean this area as soon as it is back in use. Cllr Jeff Gibson will check the bins have been emptied after the first hire.

84. WILTSHIRE COUNCILLOR REPORT - Trevor Carbin

Plan Review. Consultation has now closed. Hilperton and Trowbridge have also put in strong objections. Wiltshire Council will now produce a 'second draft' for further consultation later in the year.

B3106 Holt Lane. S106 contributions from development in the Hilperton Gap include possible funding for making the B3106 one-way northbound except for buses and cyclists. It may be some time before there is enough funding, but officers have asked for an initial steer. Councillors felt that allowing buses and cyclists to travel both ways and other traffic one way could cause confusion.

Bath Clean Air Zone started today Monday. Traffic counts on New Terrace during speedwatch are not happening at the moment, so Cllr Carbin will carry out some separately to see if there's any noticeable difference in the traffic volume.

Speedwatch. We are allowed to restart on March 29th, but as we were the last to have the device before lockdown we're now behind Trowbridge and Hilperton on the rota, so will be in action in June. Cllr Carbin has arranged to borrow a Speed Indicator Device from Trowbridge Town Council – that will probably be available in July for the month.

Litterpick is this Sunday 21st, 1030 at the Village Hall. All are welcome. Covid restrictions will apply. The daffodils we planted on the day of the autumn litter pick seem to be growing!

School Lane. As mentioned previously it's been inspected and is on the repair list, though not seen as a priority by Highways so could be some time. Parish Steward to be asked to repair the over-run.

Trees. Three new silver birches planted on The Slipway and by the canal are funded by a resident. Also the previous trees which died have now been replaced at the contractor's expense. Cllr Carbin will be putting guards on the birches to prevent strim damage.

Thestfield Drive. Work on replacing the fence around the Thestfield Drive reed bed is underway. The bin is to remain where it is. Cllr Carbin will be putting some paving slabs down by the bin when the fencing work is finished following complaints about the mud.

Grass. Cllr Carbin has had a complaint about the standard of the recent grass cutting, which has been passed on to the contractor.

Warren Rd – There have been complaints regarding cleared land near the balance pond. However Wiltshire Council are satisfied that it does not interfere with the workings of the balance pond.

85. PARISH STREET MAINTENANCE

The Steward has been clearing drains at Thestfield Bridge and Cllr Nick Woodhall has asked that the rotten wood on the bridge near Lotmead footpath be repaired. He was asked if the Parish Steward could repair the over run at the side of the footpath between Cygnet Way, preferably with hard core. There is also a disturbed kerbstone needing repositioning at Warren Road near Herbleaze. Action: Cllr Woodhall to contact the Parish Steward.
